8. City Recorder Update

City Finances & Appointment of Budget Officer

The finance reports are attached to the Council Packet.

Oregon law requires the annual appointment of a City Budget Officer. It is recommended that the Council appoint the City Recorder to be the Budget Officer, charged with drafting the budget.

Suggested Motion: I move to appoint City Recorder Alex McHaddad to be the City Budget Officer.

City Updates

The Legislative Session is in full swing. I attended the League of Oregon Cities Lobby Day with Councilor Joseph Parsons, hearing from the Governor and legislative leaders about priorities. I met with the office of Representative Jami Cate later that day to discuss the City's part in LOC legislative priorities. LOC's homelessness proposal, developed by the Oregon Mayors Association, was rejected by the Governor in her biennial budget proposal. The Ways & Means Committee historically plays a much larger role in writing the budget than the Governor, and it is still possible to lobby for its passage, but the Governor's rejection is a significant setback.

The City has some important deadlines to maintain throughout the coming months. I recommend that the Council undertake my first annual performance review in March. In April, the Council will have its first conversation about budget priorities. The annual Budget Committee will be handled in May, followed by the Council's approval of the Budget in June. Councilors should review their schedules to ensure that they have appropriate time available to participate in additional meetings to ensure that this work can be completed.

Ordinance Complaints

A complaint about the vacant lot being used for home construction by Habitat for Humanity suggested that the dwelling was not being constructed within current setback limits. Review of the property and Ordinance 19-02 verified that the home is being constructed within current setback limits.

10.a. Ordinance 23-01 Amending Ordinance 17-01

Staff Summary

The City Council held a work session on February 8th to discuss changes to City water utility rates. Ordinance 17-01 amends the City's water utility rates, including increasing the base rate from \$45 to \$47 and modifying tiers to be 2,500 gallons each rather than variably 2,500 or 5,000. Smaller tiers decrease in price in keeping with the decreased amount of included water. Tiers range from 2,500 to 30,000 gallons used per month.

THE CITY OF SODAVILLE ORDAINS AS FOLLOWS:

Section 1. Amending Water Utility Charges

The following amendments to Ordinance 17-04 Section 4.C. are adopted:

The applicable user charges for the following commodities, demands, services, activities and penalties shall be:

10.b. Ordinance 23-02 Amending Ordinance 19-02

Staff Summary

At the January 2023 regular meeting, the City Council voted to initiate an amendment to Ordinance 19-02 changing the newspaper of record for certain public hearings. Staff recommend replacing the now closed Lebanon Express with the Albany Democrat-Herald as the only suitable newspaper serving west Linn County. The Lebanon Local is published only once per month, and the weekly Brownsville Times only covers Brownsville and Halsey.

Ordinance 23-02 Amending Ordinance 19-02

THE CITY OF SODAVILLE ORDAINS AS FOLLOWS:

Section 1. Amending the City of Sodaville Zoning & Development Ordinance Section 3.104.01.C.1. is amended as followed:

1. Hearing. Before the Council may take action on a tentative plan, it shall hold a public hearing. Notification of the hearing shall be by posting notices of the hearing on the property to be developed, the Sodaville Park Community Board and Sodaville City Hall; notifying by mail the applicant and all owners of parcels or lots within 300 feet of the exterior boundaries of the proposed PUD, and publication of notice in the **Albany Democrat Herald** Lebanon Express. All notices shall be posted, published, and mailed at least 20 days prior to the scheduled public hearing.
